Agenda Changes: Add Personal Hiring of David Lee and Resignation of Board Member

Spotlight: Music by Brookings-Harbor High School Jazz Band led by Greg Goode.

Citizen Input: Chuck Weller spoke about the progress or regress of the High School Shop Classes. He thought it was a given that shop would be offered, you have to have something for kids who are not making it in other academic areas. He is concerned about programs being eliminated under the term there is "not enough money". Brian Hodge had to remind Mr. Weller he was commenting on staff members. He then commented that it hurts him to see programs cut without regards to student need.

Sue Cruickshank spoke about her concern for the lack of vocational classes in our schools. She knows from experience what vocational education classes mean to her as she did not go on to college. The classes that she took helped her to obtain employment and support her family. She is sure that the board is for all students whether they go on to college or not. It is time to address the needs all students to re-implement vocational education classes. What happened to the plan the previous superintendent spoke about that would combine all the vocational education classes to allow students to build a house. She gave several examples of companies offering grant monies at www.refresheverything.com such as Pepsi Cola.

Brian Hodge commented on vocational education. Our enrollment is declining at \$6,000 per student that is a lot of money. This next year we have a 140 seniors leaving and 104 entering. In the last three years we have to cut over \$3,000,000 just to keep the budget at a flat line of revenues. We had the budget committee meeting several weeks ago and we had zero community input at the time. The meeting was posted in the paper and was listed on the radio. These cuts are very painful for us, we are not happy to make any of them. He is truly sorry that we had to make some difficult decisions. We do have vocational education but it is different from the traditional; robotics, healthcare jobs, graphics. Graduation requirements are increasing. Schools to the north of us are cutting 10 days from their calendars. We are in the planning process to have a modified version of the traditional vocational education program after school as it is a shame to not have them. We hare not selling any of the equipment. Brian invited anyone to come to his office to talk about it, not one person has come to see him about this subject to date. We can't cut \$3,000,000 and still have everything that we want.

It should cost us next to nothing. He was going to ask about Kindergarten round up, but Linda beat him to it. We currently have 110 but you never know what will occur until school opens in the fall. We will still be offering all-day kindergarten. Brian thanked Cassidy for her great job for the board.
